

**KIIM-FM, K-HIT, 97-5 THE VIBE AND WILDCATS RADIO 1290'S "2023 MEN'S BASKETBALL
TOURNAMENT TRIP" CONTEST
OFFICIAL RULES**

The Station will conduct the **KIIM-FM, K-HIT, 97-5 The Vibe and Wildcats Radio 1290's "2023 Men's Basketball Tournament Trip"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. KIIM-FM & KCUB-AM

All online entries must be received by 11:59pm MST on February 26, 2023 to be eligible for the Grand Prize (as defined below) drawing. **Limit one (1) entry per person per day per email address.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified.
